Graduate Faculty Membership Department of Anatomy & Cell Biology January 2003

Criteria for Full Membership

- 1. The faculty member must hold a doctoral degree.
- 2. The faculty member must have a documented record of scholarly accomplishment conducted and completed as a fellow, research associate or independent principal investigator after receipt of the doctoral degree. Such accomplishment may be demonstrated by one or more of the following:
 - Publication of original research or scholarly work in journals or other outlets
 that make publication decisions on the basis of peer review (a record of
 publication of work completed after receipt of the doctoral degree must be
 demonstrated to qualify for full graduate faculty membership status)
 - Generation of support for scholarly work by submission and receipt of intramural and/or extramural grants and/or contracts
 - Invited lectures/seminars/presentations delivered at regional, national or international meetings or at institutions other than UND
 - Other regional, national or international recognition of scholarly accomplishment
- 3. The faculty member must have documentation of competence and effectiveness in teaching and/or mentoring students at the graduate level. Competence and effectiveness in teaching and/or mentoring students at the graduate level may be demonstrated by student and/or peer evaluations supportive of the faculty member's activities in one or more of the following:
 - Teaching graduate level coursework (<u>minimum of one full semester of graduate level teaching *must* be completed to qualify for full graduate faculty membership status)</u>
 - Developing and implementing graduate level curricula
 - Chairing or serving on thesis or dissertation Faculty Advisory Committees
 - Directing graduate student research
 - Advising graduate students

The term of full graduate faculty membership will continue until departmental graduate program review (every 7 years) and will continue thereafter upon demonstration of consistency in meeting the above criteria and by recommendation of the Department Chair, Departmental Director of Graduate Education or the Graduate Dean.

Criteria for Associate Membership

- 1. The faculty member must hold a doctoral degree.
- 2. The faculty member must have undertaken scholarly work conducted as a predoctoral student, postdoctoral fellow, research associate or principal investigator and, on the basis of peer recommendation, demonstrate potential for:
 - Establishment of an independent research program
 - Publication of original research or scholarly work in journals or other outlets that make publication decisions on the basis of peer review
 - Generation of support for scholarly work by intramural and/or extramural grants and/or contracts
 - Regional, national or international recognition of scholarly accomplishment
- 3. The faculty member must, on the basis of peer recommendation, demonstrate potential for and commitment to teaching and/or mentoring students at the graduate level.

The term of associate graduate faculty membership will continue until departmental graduate program review (every 7 years) and thereafter by recommendation of the Department Chair, Departmental Director of Graduate Education or the Graduate Dean provided that the above criteria are met or until criteria for advancement to full graduate faculty membership have been met.

Criteria for Advancement from Associate to Full Membership

The departmental criteria for Associate Graduate Faculty Membership and Full Graduate Faculty Membership are quite clear and distinct with regard to either "demonstrated potential for" or "documented achievement in" research and scholarly activity and teaching/mentoring. The degree requirements are the same. In order for a faculty member to be either elected directly to full membership or advanced to full membership from associate membership, *all* the criteria for full membership *must* be met.

Criteria for Assistant Membership

The Department of Anatomy & Cell Biology is not a clinical or professional practice-based department. Therefore, the faculty in the Department of Anatomy & Cell Biology would only hold the qualifications required for either associate or full membership.

Adjunct and emeritus faculty and special appointments will follow the criteria stated in the Graduate Faculty Constitution.

Atmospheric Sciences

Terminal Degree: Ph.D.

Full Member:

(Level of Scholarly Achievement)

Scholarly achievement as demonstrated through publication in refereed journals, books or authoring of a software package, and a sustained level of effort in research. There is no set quota on the number of publications or extramural grant activity. However, rough guidelines would expect publications to average more than one every two years and funding as principal investigator of more than one grant in a five-year period. These numbers are dependent on the nature of the activity (e.g., a book or large, multi-year grant would carry more weight).

(Teaching & Mentoring)

The faculty member should be active in teaching graduate courses and should receive evaluations of at least mid-range quality. Their research should include student participation. They should also have served on several student graduate committees.

Associate Member:

(Scholarly Achievement)

At this level the faculty member should have published recently in a refereed format. The individual should also be involved in research and have received external funding or submitted a proposal for externally funded research as principal investigator or co-investigator.

(Teaching & Mentoring)

The faculty member may or may not have had the opportunity to teach at the graduate level, but should at least have some interaction with graduate students in an advising or research capacity.

Advance:

The faculty should meet the criteria stated above. Essentially, this means that the individual must demonstrate a sustained quality effort in research and/or scholarly activity.

Graduate Faculty Criteria Biochemistry and Molecular Biology



The PhD is required for full, associate, and adjunct membership to the Graduate Faculty in Biochemistry and Molecular Biology (BMB). It is expected that a new hire at the assistant professor level will qualify for appointment as an associate member of the Graduate Faculty according to the criteria below. New hires at the level of associate or full professor may be appointed to the Graduate Faculty as a full member if they meet criteria for that category. The department will support the nomination of individuals with courtesy academic appointments as adjunct members of the Graduate Faculty providing they meet the criteria for associate members below.

Full Member:

Level of Scholarly Achievement

- Record of sustained publication as senior author in peer-reviewed journals
- Demonstrated ability to obtain funding to support a viable research program with a record of continuing attempts at external funding

Teaching and Mentoring

- Record of sustained and significant contributions to graduate education in a recognized graduate program
- Service on one or more PhD student committees in a recognized graduate program
- At least two years of experience serving as major advisor for an MS or PhD student in a recognized graduate program

Associate Member:

Level of Scholarly Achievement

 At least one publication in peer-reviewed journals as first author and several others, not necessarily first author

Teaching and Mentoring

- Demonstrated potential for independent development of graduate courses and/or individual lectures in area of expertise as evidenced through research seminars
- Expressed desire to develop the skills required to effectively mentor graduate students and serve on graduate advisory committees

Advancement from Associate to Full:

- Demonstration of continuous scholarly activity as indicated by publications appearing in peer reviewed journals since arriving at UND, and one or more submission of abstracts based on work done at UND
- Documented attempts at securing extramural funding
- Regular contribution of instruction at the graduate level including regular participation in Current Literature (BMB 514) and Seminar (BMB 521)
- A minimum of two years of service on one or more PhD student committees
- Demonstration of ability to successfully supervise an MS or a PhD student, in accordance with graduate school regulations for associate graduate faculty

Biology

Terminal Degree: Ph.D.

Full Member:

(Level of Scholarly Achievement)

Ph.D. completed; Ph.D. research published or in press and demonstrated postdoctoral research accomplishments

(Teaching & Mentoring)

Evidence of teaching and work with students.

Associate Member:

(Scholarly Achievement)

Ph.D. completed; Ph.D. research not published or no postdoctoral research accomplishments

(Teaching & Mentoring)

Evidence of teaching and work with students.

Advance:

Publishing of Ph.D. research and demonstrated post-doctoral research accomplishments.



Business and Public Administration

Terminal Degree: Ph.D., D.B.A, L.L.M., or J.D.

Full Member:

(Level of Scholarly Achievement):

• Research productivity exemplified by at least three refereed journal articles (or equivalent research product, for example a scholarly book). Scholarly output is expected to be produced at a consistent level over time with amount dependent on the length of the individual's academic experience.

(Teaching & Mentoring)

An eligible candidate for full membership in the graduate school must have
participated in the instruction of graduate students in tat least one of the following
ways: courses that are either solely taught or team taught, a member of thesis or
dissertation committee(s), or advisor to independent study(ies). (Note: this may
have been demonstrated at an institution other than UND).

Associate Member:

(Level of Scholarly Achievement)

• Must have completed dissertation or equivalent project required for terminal degree.

(Teaching & Mentoring)

Must have teaching experience sufficient to provide expectation of ability to teach
and mentor graduate students. Whether or not the individual has taught graduate
students is not an issue. Only those that are considered qualified to teach graduate
students will be forwarded.

Criteria for Advancement from Associate to Full Membership

• Research productivity exemplified by at least three refereed journal articles (or equivalent research product, for example a scholarly book). Scholarly output is expected to be produced at a consistent level over time with amount dependent on the length of the individual's academic experience. An eligible candidate for full membership in the graduate school must have participated in the instruction of graduate students in at least one of the following ways: courses that are either solely taught or team taught, a member of thesis or dissertation committee(s), or advisor to independent study(ies). (Note: This may have been demonstrated at an institution other than UND).

Chemical Engineering

Terminal Degree: Candidate must have obtained a Doctor of Philosophy in Chemical Engineering or closely related field. Applicability of the term "closely related field" for the purposes of this criterion shall be determined by obtaining the consensus of all Departmental faculty members who are full members of the UND graduate faculty. Examples of "closely related fields" include: Energy Engineering, Environmental Engineering, Applied Chemistry, Petroleum Processing Engineering, Thermodynamic Engineering, and Material Science Engineering.

Full Member:

(Level of Scholarly Achievement)

- a. Adequacy of scholarly achievement can vary widely depending upon the candidate's situation. Fulfillment of the requirements of this criterion, as described below, shall be determined by obtaining the consensus of all Departmental faculty members who are full members of the UND graduate faculty
- b. Candidate shall have a consistent record of publication in peer-review journals consistent with level of experience, current and former job descriptions, and area of research expertise. As a minimum, candidate shall have published at least two peer-review journal articles or have submitted at least three peer-review journal articles at the time of application for full membership. At least one of these publications must be based on work in which the Candidate is the Principal Investigator.
- c. Candidate shall have a consistent record of contract grant activity consistent with level of experience, current and former job descriptions, and area of research expertise. As a minimum, candidate shall have at least one funded research project or have submitted at least three proposals for funded research projects at the time of application for full membership.
- d. Candidate shall have experience serving as the primary research Advisor for at least one student working on graduate-level research for a period of no less than one year. The student can be an M.S. or M. Eng. Graduate student, a student accepted by the UND Graduate school into the combined MS/BS or M Eng/BS degree program, or an exceptional undergraduate student working on graduatelevel research.

(Teaching & Mentoring)

a. It is preferred that Candidate have successfully developed and taught at least one 500 level course. Because of the current staffing level in the Chemical Engineering Department, a Candidate for full membership may not have had the opportunity to teach a graduate level course prior to candidacy for full membership. Failure to have taught at least one course must be due to Departmental teaching load requirements not due to Candidate's judged ability to teach a 500 level course in order to satisfy this criterion.

b. Candidate must have served as the general faculty advisor for at least one graduate student for at least two academic semesters at the time of candidacy.

Associate Member:

(Level of Scholarly Achievement)

• There are no requirements for scholarly achievement.

(Teaching & Mentoring)

There are no requirements for teaching and mentoring.

Advance:

• Candidates for advancement must meet the same criteria as direct appointment at the full membership level.

Assistant:

• The assistant member category is not currently considered to be available to faculty members in the Department of Chemical Engineering.



Chemistry





Full Member:

(Level of Scholarly Achievement)

• The minimum level of scholarly achievement is six research publications.

(Teaching & Mentoring)

 The demonstrated level of competence in teaching and mentoring of students is experience as a postdoctoral fellow working with graduate or undergraduate students.

Associate Member:

(Level of Scholarly Achievement)

• The minimum level of scholarly achievement is a Ph.D. dissertation.

(Teaching & Mentoring)

 The demonstrated level of competence in teaching and mentoring of students at the graduate level is no prior experience.

Advance:

 The minimum level of scholarly achievement is six research publications, and experience as a postdoctoral fellow working with graduate or undergraduate students.

Assistant:

The minimum level of scholarly achievement is a thesis-based master's degree.

Civil Engineering

Terminal Degree: Ph.D. in Engineering or closely related field

Full Member:

(Level of Scholarly Achievement)

- Should be primary author on at least three articles published in refereed, civil engineering technical journals.
- Should be primary author on at least six articles published in civil engineering conference proceedings
- Should be principal investigator or co-principal investigator on at least three funded research projects
- Should have at least two years experience supervising graduate students in a graduate-level research project

(Teaching & Mentoring)

• Should have at least one year of experience teaching graduate-level civil engineering courses and one year of experience advising graduate students

Associate Member:

(Level of Scholarly Achievement)

- Should be primary author on at least one article published in a refereed, civil engineering technical journal
- Should be primary author on at least two articles published in civil engineering conference proceedings
- Should be principal investigator or co-principal investigator on at least one proposal for a funded research project

(Teaching & Mentoring)

No graduate teaching or advising experience required for associate membership

Advance:

• Satisfaction of the minimal requirements for full membership as listed above

Assistant:

- Should be primary author on at least one article published in a civil engineering conference proceedings
- Should be principal investigator or co-principal investigator on at least one proposal for a funded research project
- No graduate teaching or advising experience required for assistant membership

The School of Communication is in the process of formulating criteria for determining the various levels of membership on the Graduate Faculty. The following criteria represent the position of the Director of Graduate Studies. The School's graduate faculty will discuss these criteria on 6 October. It is hoped that a resolution, in terms of a vote on these criteria or amendments thereto, will be taken at that time.

Criteria for Full Membership

1. What is considered a terminal degree in your field?

The terminal degree in Communication is the Ph.D.

2. What do the faculty in your department consider as the minimal level of scholarly achievement required appointment to the Graduate Faculty as a Full Member? The Graduate Committee will use this information as a guide in evaluating applications. Please provide specific information regarding publication record, extramural funding and prior experience with students

Frequent contributions to the research tradition in Communication, and/or closely related fields. This may include publication in national and regional, refereed journals, editing of important anthologies, authoring of a scholarly book(s), reading of competitively selected and/or invited papers at national and regional conferences, awarding of research fellowships or some combination of the above. Whatever that combination, it should include at minimum an average of at least one national publication or conference paper per year subsequent to the candidate's earning the Ph.D. While the pursuit of extramural funding is desirable, and may be considered a positive contribution to the candidate's application, it is not a requirement for advancement to Full membership. A Full Member of the Graduate Faculty will be expected to have a significant record of mentoring students in terms of both practical issues (such as advising plans of study) as well as introducing students to a culture of research and scholarship.

3. What is the demonstrated level of competence in the teaching and mentoring of students at the graduate level required for becoming a full member?

The candidate should demonstrate the potential ability to successfully direct both Ph.D. dissertations and Masters theses. This can be demonstrated through the quantity and quality of the candidate's own scholarship as well as relevant comments on teaching and peer evaluations. The candidate must demonstrate teaching competence to the satisfaction of the School's Graduate Studies Committee by the quality of student teaching evaluations, peer review, or some combination of the two. The candidate should also have a strong record of mentoring relationships, as evidenced by student evaluation of advising and relevant comments on teaching and peer evaluations.

Criteria for Associate Membership

1. What is considered a terminal degree in your field?

Answered above (the Ph.D.).

2. What do the faculty in your department consider as the minimal level of scholarly achievement required for appointment to the Graduate Faculty as an Associate Member? The Graduate Committee will use this information as a guide in evaluating applications. Please provide specific information regarding publication record, extramural funding and prior experience with students.

Occasional contributions to the research tradition in Communication and/or closely related fields, or a demonstrated ability to conduct such research. This may include publication in national and regional, refereed journals, editing of important anthologies, publication of a scholarly book(s), reading of competitively selected and/or invited papers at national and regional conferences, awarding of research fellowships, or some combination of the above. Whatever that combination, it should include at minimum an average of at least one national conference paper per year subsequent to the candidate's receiving the Ph.D. and occasional national publications. While the pursuit of extramural funding is desirable, and may be considered a positive contribution to the candidate's application, it is not a requirement for advancement to Full membership.

3. What is the demonstrated level of competence in the teaching and mentoring of students at the graduate level required to become an associate member?

The candidate should have a successful record of teaching at the graduate level and should evidence the potential, to the satisfaction of the School's Graduate Studies Committee, to evaluate dissertations and theses. Such potential can be evidenced by student teaching evaluations, peer review, or some combination of the two.

Criteria for Advancement from Associate to Full Membership


1. What do the faculty in your department consider as the minimal requirements for advancement of an Associate Member of the Graduate Faculty to Full Membership? The Graduate Committee will use this information as a guide in evaluating applications. Please provide specific information regarding publication record, extramural funding and prior experience with students.

The criteria for Full Membership are summarized in #1, on page 1 of this document. Advancement to Full membership would be recommended if the candidate showed compelling evidence that he/she were close to meeting the criteria specified there and if it appeared that he/she would, in fact, meet those criteria at the time of, or shortly after, advancement to Full Membership.

Criteria for Assistant Membership

1. What do the faculty in your department consider as the minimal requirements for appointment to the level of Assistant Member of the Graduate Faculty? The Graduate Committee will use this information as a guide in evaluating applications. Please provide specific information regarding publication record, extramural funding and prior experience with students.

The candidate should have a successful record of teaching at the graduate level and should evidence the potential, to the satisfaction of the School's Graduate Studies Committee, to mentor graduate students and to contribute to the research tradition in Communication. Such potential can be evidenced by student teaching evaluations, peer review, or some combination of the two and by contributions to, at minimum, regional conferences (in terms of competitively selected conference papers). While the pursuit of extramural funding is desirable, and may be considered a positive contribution to the candidate's application, it is not a requirement for appointment to Assistant Membership.





Terminal Degree: Ph.D.

Full Member:

(Level of Scholarly Achievement)

- At least three full papers in journals or published proceedings.
- At least three years of teaching experience that includes graduate level courses.

(Teaching & Mentoring)

 No additional requirements beyond those for promotion and tenure, except that teaching experience must include supervision of at least one graduate student who successfully completed her/his degree.

Associate Member:

(Level of Scholarly Achievement)

- Completion of a Ph.D.
- At least one semester of teaching experience that includes undergraduate courses for computer science majors.

(Teaching & Mentoring)

• No additional requirements beyond those for tenure track positions.

Advance:

• Satisfying the requirements for full membership as described above.

Assistant:

- M.S. degree
- At least three years of teaching experience that includes upper division undergraduate courses or at least three years of experience in the computing profession.

Terminal Degree: Ph.D. in Criminal Justice or related field

Full Member:

(Level of Scholarly Achievement)

- Record of research presentations at national or regional professional meetings
- Record of scholarly publications
- Record of participation as a reviewer for national or regional journals

(Teaching & Mentoring)

- · Record of graduate level teaching experience
- Record of service on graduate thesis or dissertation committees
- Demonstrated ability to assist graduate students in the development and completion of graduate theses or dissertations

Associate Member:

(Level of Scholarly Achievement)

 Record of effective teaching and/or publications that indicate competency to serve on graduate thesis or dissertation committees

(Teaching & Mentoring)

• Demonstrated potential to work with others in the guidance of graduate theses or dissertations

Advance:

• Same as criteria for full membership

Assistant:

• Demonstrated record of scholarly ability that will be of assistance to graduate students in the development of theses or dissertations

Earth System Science & Policy

Terminal Degree: The field is multi-disciplinary. For faculty in the natural and social sciences, the terminal degree is the Ph.D. Should we add a lawyer to the faculty, the terminal degree would be a J.D. The cultural component we will focus upon is American Indian culture. We might seek an Indian scholar who has a Ph.D, but it is possible we would accept a scholar with a lesser degree—out of necessity.

Full Member:

(Level of Scholarly Achievement)

We are striving for a faculty with a range of experience. Certainly <u>quality</u> of one's publication record will be an important factor, as well as the quantity of the record. However, the Earth System Science and Policy program is focused on actions leading toward sustainability. Hence experience—for example, with a resource agency, an NGO, a business, or a government laboratory—that demonstrates creative, innovative problem-solving capabilities will be considered. Experience supervising students is definitely advantageous, but so is experience dealing with the public sector, so that a faculty member could help students learn how to do so. Full Members will be expected to help secure external funds, either by submitting grant proposals—or by contributing as co-investigators to proposals others submit. They can also secure external funding through contracts with businesses or agencies, or by securing donations and contributions (e.g., matching contributions).

(Teaching & Mentoring)

Before becoming a Full Member, a faculty candidate will have to demonstrate that some students elected to do theses, internships, or dissertations under that candidate's supervison. Furthermore, the outcome of those theses, internships, and dissertations will have to have had a demonstrable impact. ESSP requires input from several disciplines, so candidates will have to show they can teach in a team environment.

Associate Member:

(Level of Scholarly Achievement)

For the grants, contracts, and cooperative agreements that are funding ESSP, we must submit metrics. These are measures of success and achievement in line with the goal of sustainability. An Associate Member will have to have provided acceptable metrics, beginning at the end of his or her first year in the program. Metrics maybe publications in scholarly journals, but can also be innovations that beneficially change resource practices. They can be significant successes at communicating environmental information to the public. They can also be instruments built, decision support systems created, software algorithms implemented, and other tangible products.

(Teaching & Mentoring)

An Associate Member should have tutored students in field measurements, laboratory measurements, data analysis and interpretation, or instrument development. The teaching and mentoring should be capable of enabling students to conduct these activities on their own after one year of mentorship. Associate Members must also be able to work in a team environment and to teach students how to do so. Teaching will be evaluated by evaluations of students and of fellow faculty with whom the candidate has team-taught.

Advance:

Because ESSP is an integration of several disciplines, its requirements are an analgam of several sets of requirements. We don't have one-size-fits-all criteria. Furthermore, ESSP differs from some academic disciplines in that the curriculum is student-structured and action-based. Therefore the real measure is what improvements faculty, working with students, make for society. This is a notoriously difficult accomplishment to measure. We will rely on a collective assessment of impact by fellow faculty, students, and external clients with whom we engage.

Assistant:

Commitment to collaborating with other ESSP faculty to address problems and opportunities that transcend individual disciplines.

Educational Leadership

Terminal Degree: Ph.D. or Ed.D.

Full Member:

(Level of Scholarly Achievement)

The publication of a scholarly book as the single author would meet the criteria. The publication of two or three scholarly book chapters, depending on the depth of scholarship and done as a single author, would meet the criteria. The accomplishment of any three to five of the other items identified in the preceding list as a single author or presenter and at a substantial level of scholarship would meet the criteria. The accomplishment of any three to five of these criteria would include at least two peer-reviewed publications in journals on the national level. A more substantial body of scholarly publication at the regional and state level that was judged to be of excellent quality might be sufficient if it also included at least another criterion. This more substantial body of scholarly publication could include how to implement best practices.

In addition, the criteria would include supervising the research work of a master's level student on the Independent Study from conception of the research idea to completion of the work. It would also include supervising the research work of a master's level student on the thesis or the specialist diploma student on the independent study. It would also include participating on the committee of a doctoral level student on the dissertation from conception of the research idea to completion of the work.

(Teaching & Mentoring)

The faculty member would need to be consistently evaluated in teaching performance as either adequate (which in Educational Leadership is taken to mean satisfactory) or excellent in probationary and third-year evaluations by department faculty and the department chair.

Associate Member:

(Scholarly Achievement)

• Either the Ph.D. or Ed.D.

(Teaching & Mentoring)

• Either the Ph.D. or Ed.D.

Advance:

A first-year faculty member with an earned doctorate would be expected to meet the requirements as described under "criteria for full membership". An experienced faculty member coming with an established and current record showing a combination or an emphasis in peer reviewed publication, funded research grants, juried scholarly presentations, and supervision of a number of doctoral dissertations would be expected to continue that performance at the rates suggested in the "Educational Leadership Departmental Criteria for Research and Writing". These scenarios seem to represent the extremes. A person in between would be expected to perform at an in-between level.

Descriptions of Teaching for the Department of Educational Foundations and Research

Inadequate: *Teaching* – Evidence of poor teaching; not available to students; low student evaluation ratings; inadequate research advisement.

Adequate: *Teaching* – Fair teaching and adequate research advisement; only minimally available to students; average student evaluation ratings.

Adequate-moving-to-excellent: *Teaching* – Effective teaching; recognized as a good research advisor; available to students; rated by students as a good, effective teacher.

Excellent: *Teaching* – Highly effective teaching in the classroom and as research advisor; has sustained this level of performance over the years; is available to students; has maintained consistent Good-to-Excellent ratings by students.

Electrical Engineering

Terminal Degree: Ph.D. in Electrical Engineering or related field.

Full Member:

(Level of Scholarly Achievement)

Faculty shall have published in Journals and/or Conference Proceedings.

(Teaching & Mentoring)

Faculty shall have successfully directed thesis research of students obtaining the Master of Science degree at the University of North Dakota.

Associate Member:

(Level of Scholarly Achievement)

Faculty must show the potential to direct independent research in their field of expertise.

Terminal Degree: In the Department of History the terminal degree is considered to be the Ph.D. However, the less common Doctor of Arts Degree (DA) and in exceptional circumstances the MFA (for an historian of art) and the MA or MS in Library Science/Archival Science would also be deemed to be terminal degrees.

Full Member:

(Level of Scholarly Achievement)

The History Department considers the following to be the minimum requirements for full membership on the graduate faculty: (a) completion of the appropriate terminal degree; (b) service on one or more graduate-level student committees - preferably as the advisor; (c) the teaching of at least one graduate-level seminar or of one of our upper division courses which carry graduate credit; and (d) evidence of scholarly development via publication of research findings (either as a monograph or as a journal article or articles - we do not stipulate a specific number. We also make allowance for the slowness of academic publishing in the humanities, thus works which are accepted and/or in press, or in the case of book-length studies, which have been contracted for by a publisher, are deemed to be strong evidence of scholarly achievement.).

We also view conference paper presentations, formal commentaries offered on conference papers and invitations to serve as a peer-reviewer of manuscripts for journals and university presses as well as invitations to write reviews of works within the scholar's field(s) of expertise as evidence of scholarly recognition. Such invitations, when accepted and successfully completed, may substitute for other forms of research/publication work listed above.

(Teaching & Mentoring)

As noted in #2 above we expect anyone seeking full membership in the graduate faculty to have served on one or more graduate-level student committees - preferably as the advisor - and to have taught at least one graduate-level seminar or one of our upper division courses which carry graduate credit.

As a department we do not separate our scholarship from our work with graduate students. Thus, every faculty member is expected to serve as a role model for our graduate students by maintaining an active research agenda and participating in the "life of the profession" at conferences, in professional associations, etc. Mentoring takes place in many different ways, and as a Department we are well aware of the role played by individual faculty members in working with our graduate students - both in and outside of the "formal" classroom setting. This awareness will always be part of the Chair's nomination of individual faculty members for full membership.

Associate Member:

(Level of Scholarly Achievement)

The History Department considers the following to be the minimum requirements for associate membership on the graduate faculty: completion of the appropriate terminal degree or ABD status with strong evidence of imminent completion.

Typically new faculty members are expected to apply for associate membership status as soon as they are hired so that they may take part in our extensive graduate program. Because of this our recruitment strategy of the 1990's to the present has focused upon hiring those who have Ph.D. in hand and teaching experience. We do not, however, stipulate publication requirements at the time of hiring - so we do not expect this of new applicants for associate membership on the graduate faculty.

(Teaching & Mentoring)

As noted in #2 above, the History Department sees associate membership as the appropriate entry-level status for the quality of faculty we are presently hiring. Only in very rare cases would we expect a new faculty member to have any substantive experience in working with graduate students. In such cases we would typically encourage such a faculty member to apply directly for full membership on the graduate faculty.

Advance:

If the faculty member in question had been hired ABD (an unlikely occurrence), the History Department would expect completion of the terminal degree as an absolute prerequisite for advancement. In typical cases the Department would expect the following for advancement to full membership: (a) service on one or more graduate-level student committees - preferably as the advisor; (b) the teaching of at least one graduate-level seminar or of one of our upper division courses which carry graduate credit; and (c) evidence of scholarly development via publication of research findings (either as a monograph or as a journal article or articles - we do not stipulate a specific number. We also make allowance for the slowness of academic publishing in the humanities, thus works which are accepted and/or in press, or in the case of book-length studies, which have been contracted for by a publisher, are deemed to be strong evidence of scholarly achievement.).

We also view conference paper presentations, formal commentaries offered on conference papers and invitations to serve as a peer-reviewer of manuscripts for journals and university presses as well as invitations to write reviews of works within the scholar's field(s) of expertise as evidence of scholarly recognition. Such invitations, when accepted and successfully completed, may substitute for other forms of research/publication work listed above.

Extramural funding is not as much a consideration in our field as it is in many of the sciences. Thus, in very few cases would this be taken into consideration - and the lack of such funding would be viewed as the norm, not the exception to the rule.

Assistant:

The History Department has never used this category and so has never set criteria for it. Typically, "clinicians" or "practitioners" whom we might wish to utilize within our graduate program - archivists, public historians, museum curators etc. - already possess the appropriate degrees to qualify for Associate or Adjunct status. We may, however, revisit this issue in the future and would like to reserve the right to add an addendum to these criteria.



State licensing law requires a social work license for teaching, which presumes a social work degree.

Full Member:

(Level of Scholarly Achievement)

A wide variety of scholarship, including applied scholarship, would be considered appropriate for this qualification. Normally, full membership would require (1) at least several practice, policy or planning reports; (2) at least some publication in refereed journals; and (3) several publications in a variety of other venues such as research reports, book chapters, or books.

(Teaching & Mentoring)

The full member should be a regular and successful teacher of graduate courses, with an established record of original research demonstrating the ability to mentor research.

Associate Member:

(Level of Scholarly Achievement)

The associate member will need to show the qualifications to work with MSW students completing independent studies, which would include at least two of the following: (1) knowledge of research methods, (2) at least two years of practice experience with a specified client group, or (3) a doctoral degree.

(Teaching & Mentoring)

The associate member should have been a successful teacher and advisor at the graduate level.

Advancement:

Advancement would require that the above criteria for full membership have been met: Specifically, an MSW and/or doctoral degree and at least five written or published works from among the following: (1) practice, policy or planning reports; (2) publication in refereed journals; and (3) a variety of other publications such as research reports, book chapters, or books. Finally, advancement to full membership requires evidence of regular and successful teaching of graduate courses, and an established record of original research demonstrating the ability to mentor research.

Assistant:

The minimum requirement would be an MSW degree and practice expertise in the area for which the member is appointed.

Sociology Department Criteria for Membership on the Graduate Faculty at Various Ranks¹

The Department of Sociology has no specific requirements for faculty members to be appointed to the Graduate Faculty beyond those specified in the Graduate Faculty Constitution. Of particular relevance to the Department are the ranks of "Full" and "Associate" membership, the definitions of which and criteria required are excerpted below from the Graduate Faculty Constitution. These are the criteria we use in deciding to nominate a faculty member to the graduate Faculty at these two ranks.

1. Full Membership

Full membership will be available to experienced members of the faculty qualified to direct the research, theses, dissertations, and independent studies of graduate students.

Responsibilities

• Upon their election to the Graduate Faculty, full members may act as chairs of a student's Faculty Advisory Committees, serve as principal supervisors for thesis or dissertation research, and be responsible for the advising of students.

Qualifications

Fulfillment of these criteria will be determined by prospective faculty member's department.

- Holding of the highest earned degree in the field or demonstration of the equivalent scholarly or creative accomplishment.
- Record of scholarly or creative accomplishment conducted and completed as principal investigator, writer, or artist after receipt of degree. Such accomplishment may be demonstrated by publication in outlets recognized throughout the discipline or by regional or national recognition of creative endeavors.
- Demonstration of competence in the teaching and mentoring of students at the graduate level. Demonstrated experience educating graduate students (e.g., teaching graduate level course work, chairing or serving on thesis or dissertation committees, and advising non-thesis students).

Term

• Terms of full members will continue until program review or other appropriate interval and will continue thereafter upon recommendation by department/program chair or dean.

2. Associate Membership

Associate membership will be available to those members of the faculty who have yet to demonstrate the "record of scholarly or creative accomplishment" and the "demonstrated competence educating graduate students" required for full membership. Responsibilities

• Associate members have all the privileges and responsibilities of full members except that they may not chair a doctoral student's Faculty Advisory Committee, direct the dissertation research of a doctoral student, or be eligible for election to the Graduate Committee; however, an associate member may chair a doctoral student's faculty advisory committee and direct the

dissertation research if approved by the Dean of the Graduate School and under the direction of a mentor appointed by the Dean of the Graduate School.

• Upon their election to the Graduate Faculty associate members may be appointed as chairs of thesis Advisory Committees, advisors for non-thesis students, or as members of Thesis and Dissertation Advisory Committees.

Qualifications

• The holding of the highest earned degree in the discipline or its equivalent in accomplishment will meet the qualifications for this category.

Term

• Terms of associate members will continue until program review or other appropriate interval and will continue upon recommendation by department chair or dean.

Terminal degree: Ph.D. or Ed.D.

1. Full Membership

Hold highest degree in the field

- Record of scholarly accomplishment conducted and completed as principal investigator or writer.
 Such accomplishment may be demonstrated by publication in outlets recognized throughout the discipline.
- Demonstration of competence in the teaching and mentoring of students at the graduate level.
- Demonstrated experience educating graduate students (i.e., competency should be demonstrated
 in at least two of the following areas: teaching graduate level course work, chairing thesis or
 dissertation committees, serving on thesis or dissertation committees, and advising non-thesis
 students).

2. Associate Membership

- Hold the highest earned degree in the discipline
- Must demonstrate to the Department Chair of Teaching and Learning, a sufficient level of scholarship to chair a thesis or doctoral committee (under the mentorship of a full member of the Graduate Faculty)

3. Assistant Membership

• Election to assistant membership is based on professional qualifications, experience, recommendation of the department chair, and approval by the EHD dean.

4. Adjunct Membership

- Requires that an appointment be made as a university adjunct professor
- Hold highest earned degree in his or her field
- Demonstrate scholarly activity in peer-reviewed outlets recognized throughout the discipline

5. Emeritus Membership

• Anyone who achieves emeritus status in their department and has been a member of the Graduate Faculty will retain the rights of their graduate faculty status.

6. Special Appointment

 Normally, expected to hold a terminal degree in discipline and record of research accomplishments, and service on advisory committees appropriate to special appointment

Criteria for Full Membership

1. What is considered a terminal degree in your field

Theatre has two terminal degrees. Scholars of dramatic literature, theatre history, dramatic theory and criticism, and performance theory generally hold a Ph. D. Professors whose training and/or professional experience focuses on practical aspects of theatre and who specialize in areas of performance such as acting, directing, and design generally hold a Masters of Fine Arts degrees. Persons who specialize in dramaturgy or theatre management may hold either a Ph. D. or an MFA. Please note that an MFA is different from a Master's degree. An MFA is a terminal degree.

- 2. Minimal level of scholarly achievement required for a Full Member In our particular department, which is relatively small, professors are expected to maintain both a scholarly profile and a performance vitae. Because of the multiple demands, we place less emphasis on publication since our faculty must meet the research demands of performance as well as scholarly writing. That said, we expect Ph. D's to demonstrate some publication, but have no specific number of publications or description in our criteria for advancement to full membership on the graduate faculty. We do expect the professor to be active and demonstrate new work (presentations at conferences or publications) annually. Should we add to our faculty, we may be able to afford the luxury of giving faculty released time for scholarly research for book length work. That is not possible at this time.
- 3. Demonstrated level of competence in the teaching and mentoring of students Faculty members are expected to have served on at least two thesis committees and to have chaired at least one thesis. They are expected to have taught or mentored graduate students in class or in production work.

Criteria for Associate Membership

- 1. What is considered a terminal degree in your field: An M.F.A or a Ph. D.
- 2. Minimal level of scholarly achievement required for an Associate Member Associate status requirements vary for each faculty member and is dependent on one's background. Experience in professional and/or educational theatre is generally equal to scholarly work. We expect a demonstration of promise for publication from scholar
- 3. Demonstrated level of competence in the teaching and mentoring of students For those faculty who have a significant background in professional theatre, consideration is given to any teaching the candidate has done in his or her professional capacity. Fore example, we recently hired a faculty member who had

For those faculty who have a significant background in professional theatre, consideration is given to any teaching the candidate has done in his or her professional capacity. Fore example, we recently hired a faculty member who had managed her own teaching studio for actors. For faculty who have a stronger teaching background from previous employment, we expect a demonstration of teaching graduate level classes, serving on thesis committees, or, at least, teaching upper level undergraduates.

Criteria for Advancement from Associate to Full Membership

1. Minimal requirements for advancement of an Associate member of the Graduate Faculty to Full Membership

We expect new work in one's area of specialization (production or scholarship) and the experience of serving on at least one thesis committee. In addition, we expect the faculty member to have taught and/or mentored graduate students at this university.

Criteria for Assistant Membership

1. Minimal requirements for appointment to the level of Assistant Member of the Graduate Faculty

The Department of Theatre Arts does not anticipate a need for Assistant Membership for faculty at this time.
