Major in Community Nutrition - add N&D 330; split N&D 342 to N&D 341/342; increase credit of 1 to N&D 440; N&D 200 deleted and content added to N&D 341/342 as a result of requirement changes to Dietetics major

Major in Dietetics add N&D 330; split N&D 342 to N&D 341/342; increase credit of 1 to N&D 440; N&D 200 deleted and content added to N&D 341/342; additional 4 credits added to N&D 498; changes result from University Essential Studies requirements and new requirements by the dietetic programs accreditation requirements

M.A. in English addition of Portfolio Thesis option;

M.A. and Ph.D. in English Language and Literature change foreign language from an admission requirement to a degree requirement in the M.A. program; remove foreign language as an admission requirement in Ph.D. program

B.S. with a major in Mathematics eliminate requirement for additional writing course; replace current linear algebra core requirements (either 327 or 442) with a more specific requirement (207); add Math 488 to core requirements; reduce number of required sequences from two to one and update the list of available sequences to reflect current offerings; add a breadth requirement
