Mr. Newman called attention to the Election for Senate Committees. The results are attached to the Senate agenda.

Mr. Armacost provided the following legislative updates. Mr. Armacost thanked the University Senate for the leadership during this academic year. Mr. Armacost recognized Mr. Newman's leadership as chair for this academic year. The appropriation bill (HB 1003) has passed the legislature, but has not been signed by the governor. There are increases of a 6% and 4% merit pool available for raises in 2023 and 2024. Mr. Armacost also thanked Ms. Wahl for her student leadership. The post-tenure review bill was defeated. The specified concepts (SB 2247) passed by guaranteed academic freedom and freedom of speech. It appears that the UND campus already complies with new gender identity laws. The concealed carry bill on campus was defeated. The UND Leads strategic plan implementation team will be co-chaired by Ryan Zerr and Angie Carpenter.

Ms. Legerski provided a Council of College Faculties update. The majority of respondents stated that they would like to extend the contract. There is a committee that will be formed to review post-tenure review processes.

Ms. Cox provided an update from Staff Senate. Tonight, there will be a May the Fourth Be with You trivia context. New senate leadership will begin May $10^{\rm th}$. Andria Spaeth will be the new president.

Ms. Wahl provided the following updates on Student Government. The last business meeting was last night. There is a new Cassie Gerhardt Servant Leadership award. It was an honor to be in this position and working with everyone. Ella Nelson will be the new Student Senate president.

Mr. Link provided the following updates from the Provost Office. The new strategic plan has been launched. Mr. Link provided examples of items initiatives already underway for each pillar. Next year we will have our HLC reaffirmation site visit. Commencement season is upon us. Please join us to celebrate their successes.

Ms. Marasinghe provided the following updates from the Office of the CIO. There are several summer projects underway. There will be an update to a new virtual private network to use. The telephone system will be moving to the cloud. Go live will now be the middle of June. Citrix will be disabled this summer. Apporto will be the new solution. The UIT helpdesk has moved to the cloud. Starfish retention solutions will be replaced with Civitas over the next year.

Dr. Zarrina Talan Azizova (she/her/hers) is an associate professor of Higher Education in the department of Education, Health and Behavior Studies. She is also a program director for M.S. in Higher Education. She taught at Oklahoma State University where she completed her M.S. in Higher Education/ Comparative International Higher Education and Ph.D. Educational Leadership and Policy Analysis/Higher Education with an emphasis on Classical and Contemporary Sociological Theories. She is originally from Uzbekistan where she completed her Bachelor's degree in Roman-German philology.

Dr. Azizova's research centers on the issues of postsecondary access and student success to understand and advance equity-conscious educational practices for diverse students. She has published several solo and co-authored peer-reviewed articles and book chapters. She regularly presents papers at the primary scholarly conferences in higher education: the Association for the Study of Higher Education (ASHE) and the American Educational Research Association (AERA) Division J (Postsecondary Education). She contributed to the expert report for court proceedings in Smith v. Regents of the University of California (2020) that argued against the use of discriminatory SAT and ACT scores in the UC's admissions. Currently, she serves as an advisory board member for the NSF Advance Grant and an external evaluator for the NSF S-STEM grant at UND. She also collaborates with several STEM education faculty to secure a grant support for the research project and anti-deficit partnership framework on broadening participation in engineering education and the workforce in North Dakota. Dr. Azizova is a second-term member of the editorial boards of the Journal of College Student Development and the Journal Committed to Social Change on Race and Ethnicity. She chaired and organized the Career Success Workshop for International Students and Scholars for ASHE and twice co-chaired the Division J conference program for AERA. In Fall 2022 she was honored with the invitation from Lumina Foundation to join World Council for Intercultural and Global Competency, UNESCO Story Circle methodology, and hundred other selected professionals for the global forum Intercultural Competence and the Future of Work in Washington D.C. This work aims to build stronger global networks across various educationserving sectors and academic disciplines to share DEI expertise, engage in inclusive practice, and advance equity-oriented initiatives domestically and globally.

Dr. Azizova teaches graduate courses and advises doctoral and master's students. Her teaching portfolio aligns with her research expertise and practice-oriented goals. She received an honor to be nominated and awarded *Excellence in Graduate Teaching and Advising* in the College of Education and Human Development in the Spring of 2022.

Dr.Azizova has served UND in various initiatives and committees, including the two major ones: as a member of the Taskforce on the Future of Education at UND and a co-chair of the Student Success through Academic Excellent team of the UND LEADS Strategic Plan Development. She is an elected representative from the EHBS to serve as a Senate member at UND (2022-2023, 2023-2024).

Michael Dodge

Michael S. Dodge currently serves as Interim Director of the UND Honors Program, as well as Associate Professor & Graduate Program Director in the Department of Space Studies at the University of North Dakota. Prof. Dodge received his LL.M. degree in Aviation & Space Law from McGill University in the Spring of 2012 (thesis: "Global Navigation Satellite Systems (GNSS) and the GPS-Galileo Agreement"). Before attending McGill, he obtained his J.D. in 2008 from the University of Mississippi School of Law, where he was also the first recipient of the Certificate in Remote Sensing, Air, and Space Law. He obtained dual degrees in B.S. (Biological Sciences) and B.A. (Philosophy) in 2005, from the University of Southern Mississippi.

While at UND, Prof. Dodge has served as a Senator-at-Large for the University Senate (2016 – 2020), Senator from the JDO School of Aerospace Sciences (2023 – present), and has served on the Library and Essential Studies committees for Senate. He served as Chair of the Essential Studies Committee for the 2019 – 2020 year. In 2022, he was a founding member of the UND LGBTQ+ Faculty Staff Association, and was the chair of the organization from 2022 – 2023. Prof. Dodge also serves as an adjunct for the UND School of Law.

Prof. Dodge's research has included GNSS law, remote sensing law & regulation, environmental regulation of outer space, concepts of sovereignty and ownership rights in space, and the nexus of remote sensing technology with global humanitarian law and disaster relief law. Current studies include examination of future environmental regulatory structures for orbital space, as well as domestic United States legislation and its relationship with the precept of non-appropriation in outer space, including an analysis of the ownership of celestial resources from potential asteroid mining operatio

Prof. Dodge teaches several courses for Space Studies, including Space Politics and Policy (SpSt 560), Space Law (SpSt 565/LAW 351), Remote Sensing Law and Policy (SpSt 575/LAW 352), and Space & the Environment (SpSt 545). These courses include a multitude of historical, political, and legal facets to space activities, and cover subjects such as legal issues in space exploration; regulation, privacy law, and constitutional concerns surrounding the use of remote sensing technology; licensing and regulatory requirements for space activity; the historical and evolutionary nature of space policy (both nationally and internationally); public international law; and domestic United States legal governance of space activity.

Faculty Representative on Senate Executive Committee

James Grijalva

James M. Grijalva is the Friedman Professor of Law at the School of Law, and has been at UND since 1994. His teaching and research focus on the intersection of federal Environmental, Indian and Administrative law. Selected University and NDUS service includes: Faculty Advisor to the SBHE (2 terms); NDUS Faculty Compensation Committee; NDUS Intellectual Property Task Force; North Dakota Higher Education Roundtable; Chair, UND University Senate; UND University Senate Revision Committee; Co-Chair, UND School of Law Dean Search Committee.

Sandep Singhal

Sandeep is passionate about his research focused on identifying the key elements to understanding intrinsic and extrinsic factors which is having a major impact on cancer diagnoses and may affect patient response to treatment. He has brought a number of research grants to the university for his efforts in bioinformatics and artificial intelligence. His research in this area was recognized globally, and published in leading high impact scientific journals, including, Journal of Clinical Oncology (JCO), Journal of Clinical Investigator (JCI) insight Nature genetics, and Nature Communications biology. He is serving as an editorial board member of Nature Scientific Report, and Cancer MDPI.

He has successfully established several national and international collaborations and also serves as Adjunct faculty at Columbia University Medical Centre New York, Director at ND INBRE (Bioinformatics division) and member of several scientific communities such as American Association for Cancer Research (AACR), The American Society of Clinical Oncology (ASCO), The Society of Toxicology (SOT). He received DaCCoTA Scholars Award and Postdoctoral Seed Funding Program Award 2020.
