2024 QA Case Reviews (Jan – Jun) QA Case Review Findings

The Quality Assurance (QA) Case Reviews is an important source of qualitative information to identify how North Dakota's child welfare system functions, including areas of practice strengths and needs. This information helps Children and Family Services (CFS) and the ND Continuous Quality Improvement (CQI) Council target areas for further analysis and improvement.


The standardized federal Onsite Case Review Instrument (OSRI) evaluates safety, permanency, and well-being outcomes in foster care and in-home services cases. Seven outcomes are used to monitor performance; each outcome is rated as substantially achieved, partially achieved, not achieved, or not applicable. Each outcome has one or more case review items to inform outcome ratings. There are a maximum of 18 case review items. Each case review item is rated as a strength, area needing improvement, or not applicable. Ratings are based on case practice during each review period's "period under review" (PUR). 










CHILD DEMOGRAPHICS - IN-HOME SERVICE CASES (n=16)

CHILD DEMOGRAPHICS - FOSTER CARE CASES (n=26)






REASON FOR AGENCY INVOLVEMENT – ALL CASES






SAFETY OUTCOME 1: Children are, first and foremost, protected from abuse and neglect.




SAFETY OUTCOME 2: Children are safely maintained in their homes whenever possible and appropriate. 71% Substantially Achieved (Goal is 95%)




PERMANENCY OUTCOME 1: Children have permanency and stability in their living situations.



PERMANENCY OUTCOME 2: The continuity of family relationships and connections is preserved for children. 88% Substantially Achieved (Goal is 95%)








WELL-BEING OUTCOME 1: Families have enhanced capacity to provide for their children's needs. 48% Substantially Achieved (Goal is 95%)
