May is National Foster Care Month

This year's theme for 2024 National Foster Care Month has been designated "Engaging Youth, Building Supports, and Strengthening Opportunities." Specifically, this year's national theme encourages young people to be part of their case plan, while encouraging agencies to ensure supports and services are readily available to meet the needs of children. This theme continues to align with Children and Family Services Section's mission of "Safe Children-Strong Families."

This month we want to recognize the children who have endured resilience and perseverance while placed out of the home. This month also is intended to show appreciation for the dedication and hard work of those engaged in the child welfare system. This includes; relatives, foster care providers, custodial agencies, juvenile court, child welfare professionals, community service providers, and other partners. The collaboration and teamwork of all these entities is essential to ensure the safety, permanence, physical and mental well-being of children in care.

Cory Pedersen, Director of Children and Family Services stated, "Foster care serves as a temporary safety service for children, while strengthening supports and opportunities for the families." Pedersen went on to note, "National Foster Care Month is a time to recognize all of those involved in the child welfare system. This year's theme surrounding engaging young people, is both timely and important. Children have the right to be involved in their case plan and we believe strongly that this is necessary." On any given day, North Dakota has 1,250 children in foster care, with nearly 850 licensed foster care providers and numerous relative caregivers opening their homes to provide a safety service to children in need of out of home placement. Relatives and licensed foster care providers are a support to maintain child safety, meet daily needs, and engage in family connections until reunification or other planned permanent options can occur.

The theme of this year's National Foster Care Month, "Engaging Youth, Building Supports, and Strengthening Opportunities" is the inspiration for May's Pride Link. Really this particular theme/topic touches on a few if not all of the Pride competencies, but in this edition, we will be highlighting the Pride competency, "Meeting children's developmental needs and addressing developmental delays". Specifically, focusing on foster youth and young adults and how we can better engage them, provide supports and opportunities to meet their developmental needs from adolescents to transitioning to adulthood.

First, for us as foster care providers or child welfare professionals, it is always beneficial to continue to gain better empathy or understanding for the challenges that youth in foster care experience. The short video, "From Passenger to Pilot" from Spaulding For Children talks from the perspective of a youth in foster care and how they may feel as they are transitioning to adulthood and the need for youth and/or young adults to be in the driver's (or pilot's) seat when it comes to planning for their life. In addition, the video explores feelings of loss, trauma, and powerlessness that youth may experience as well as the need for authentic engagement from the adults and caregivers in their lives to help youth gain control of their own life and be back in that driver's (or pilot's) seat. CHILDREN'S FOSTER CARE MONTH

WHEREAS, keeping children safe and families strong is the key to healthy communities, while providing services and support to families so they can stay together or be reunited as soon as possible is the primary goal of the North Dakota child welfare system; and

WHEREAS, North Dakotans have a long-standing tradition of helping the community, while opening their hearts and homes to children in need of stability and support; and

WHEREAS, North Dakota foster care providers are role models and provide important mentoring to parents, helping them enhance relationships with their children and maintain family connections until reunification can occur; and

WHEREAS, Children's Foster Care Month is an opportunity to recognize nearly 900 licensed foster families and numerous relative kinship caregivers who provide quality care to 1,200 children and adolescents placed in foster care; and

WHEREAS, there is an ongoing need to engage family and kinship caregivers immediately, while working to recruit additional foster care providers and retain current foster care providers; and

WHEREAS, grandparents, aunts, uncles and other close family members and relative caregivers have an important role in providing normalcy, stability and family connections to children and adolescents who are not able to remain with their biological parents; and

WHEREAS, relative caregivers, foster care providers, human service zones, child welfare professionals and other partnering agencies involved in foster care deserve recognition this month and all year long for their continued teamwork and steadfast devotion to the safety, permanency and well-being of children and adolescents; and

WHEREAS, this annual observance calls attention to the value of foster care as a temporary service that provides safety and supports for the engagement of children and adolescents, while strengthening opportunities for their families in our North Dakota communities.

NOW, THEREFORE, as Governor of the State of North Dakota, I do hereby proclaim May 2024, CHILDREN'S FOSTER CARE MONTH in the State of North Dakota.

National Foster Care Month:

Engaging Youth. Building Supports. Strengthening Opportunities

May is a beautiful month offering longer days and more sunshine to enjoy, the flowers start to bloom, and it is a sign that summer is right around the corner. May is also a special time to spread awareness about foster care! This year's National Foster Care month theme is "Engaging Youth. Building Supports. Strengthening Opportunities." This theme emphasizes the importance of authentic youth engagement, encouraging healthy relationships that will last a lifetime, and helping youth gain opportunities as they prepare for adulthood. According to the Child Welfare Information Gateway, each year roughly 20,000 young adults transition out of foster care without a permanent family. This transition does not come easy, especially if support, connections, and opportunities are missing. Oftentimes, this leads to higher risk for adverse outcomes for youth aging out of foster care. Preparing youth in foster care for their move into adulthood is crucial, and this needs to start long before their 18th birthday. During National Foster Care month and beyond, consider how you can ENGAGE youth in preparing for adulthood, help them BUILD strong connections, and gain access to OPPORTUNITIES that will lead to a successful transition.

The Child Welfare Information Gateway has captured stories of foster care from individuals and families who have been impacted by the child welfare system.
